MOTION WAS SUSTAINED to adopt the docket as amended.

Welcome from the President of Alma College was given by Dr. Nick Piccolo, Vice President for Student Life.

MOTION WAS SUSTAINED to seat the following as Corresponding Members: The Rev. Stephen Keizer (Philadelphia) and the Rev. David Weber (Lake Michigan).

MOTION WAS SUSTAINED to approve the Consent Agenda which included:

1. Approved the minutes of the March 7, 2017 Stated Meeting of the Presbytery.

A short **BREAK** was taken prior to **WORSHIP**.

WORSHIP was led by the Rev. Drs. Joseph Novak and Rhonda Myers and included a **CELEBRATION OF THE LORD'S SUPPER**, sermon led by the Rev. Dr. Rhonda Myers and an **OFFERING** to Presbytery of South Louisiana for relief from the New Orleans tornadoes, with preference for application to the housing facility for Project Homecoming volunteers which was destroyed.

Visitors, new clergy and elder commissioners were introduced.

A short **BREAK** was taken prior to the Equipping for Ministry time.

During the **EQUIPPING TIME**, Stephan Keizer of the Presbyterian Foundation gave a preview of his workshop that he will be leading as part of the Stewardship event on June 24, 2017 at Flint-First.

Adjourned for lunch at 12:00 pm following prayer by the Moderator.

Reconvened at 12:45 pm following prayer by the Moderator.

The report of the **ADMINISTRATIVE COMMISSION** for Alma-Eastminster was given by the Rev. Mary Anne Evans-Justin.

MOTION WAS SUSTAINED to dissolve the congregation of Alma Eastminster Presbyterian Church, Alma, MI effective June 6, 2017. Upon dissolution, and subject to the conditions of G-4.0205, all property of the Alma Eastminster Presbyterian Church congregation is transferred to the Presbytery of Lake Huron.

A celebration of the life and ministry of Alma-Eastminster was led by the Revs. Scott Kroener and Mary Anne Evans-Justin.

MOTION WAS SUSTAINED to dissolve the Administrative Commission to close Alma-Eastminster.

The **COMMISSION ON MINISTRY** report was given by Elder Janie Gugino.

A **CELEBRATION OF THE MINISTRY** of the Rev. Ken Parker who is retiring as Pastor of Saginaw-Countryside Trinity was led my Elders Chris Wolf and Mary Ann Parker.

A **CELEBRATION OF THE MINISTRY** of the Rev. Ken Hetzel who is retiring as Pastor of Croswell-First was led by Elders Chris Wolf and Sally Pomeroy.

The Commission on Ministry reported that it took the following actions on behalf of presbytery:
